Q4 How far is the site from the main campus?







Q9 Does your branch campus conduct Unit or Self-Assessment reviews?





Q10 If yes to question #9, how often are the Unit or Self-Assessment reviews administered at the branch campus?





Q11 If yes to #9, does your institution contract with an external consultant(s) to review the Unit or Self-Assessment review documents and to conduct a site visit of the branch campus?





Q12 If yes to question #11, how often are external consultant(s) secured that visit the branch campus?














