

Jerry Farley, Ph.D., is the 14th President of Washburn University. He joined Washburn in July 1997 after spending over 28 years in higher education in Oklahoma. He most recently held the position of Vice President of Community Relations and Economic

Development at the University of Oklahoma. He had previously served as Administrative Vice President and Chief Financial Officer at the University's Norman campus, and the Health Sciences Center at Oklahoma State University.

He holds a baccalaureate degree in finance and accounting, an MBA and earned a Ph.D. in Higher Education Administration all from the University of Oklahoma. He is a CPA and has been president and chairman of the board of several state and national professional organizations. He has authored or co-authored numerous articles and books in his field-not-for-profit finance and accounting.

Dr. Farley has served on local and state boards for the American Red Cross, American Cancer Society, United Way, state and local chambers of commerce and economic development corporations. He was a trustee of the Oklahoma Teachers Retirement System. He was the recipient of the Robinson Award, a national award for outstanding contribution to the field of college and university accounting, and was inducted into the Oklahoma Higher Education Hall of Fame in 1997.
